### Summer 24 Important Dates

Monday, May 13th: Summer I and Summer Full Classes Begin/Last Day to Register

Monday, May 20th: Last Day to Add Summer I and Summer Full Classes

Monday, May 28th: Drop Summer I and Summer Full Classes

Sunday, June 30th: Summer | Classes End/Last Day to Withdraw

Monday, July 1st: Summer 2 Classes Begin/Last Day to Register

Monday, July 8th: Last Day to Add Summer 2 Classes

Monday, July 15th: Last Day to Drop Summer 2 Classes

**Sunday, August 18th:** Summer 2 and Summer Full End/Last Day to Withdraw

### Summer 2024 - FastPass & FastPass Lite

For Traditional Undergraduate students, if you'll be taking a course during Summer 24, make sure to file your 24-25 FAFSA now at StudentAid.gov. For FastPass or FastPass Lite eligible students, you'll receive an updated aid package with your summer FastPass financial aid listed. Don't forget to file your 24-25 FAFSA to see if you qualify for any additional financial aid to help cover your summer fees!

# Satisfactory Academic Progress (SAP)

At the end of spring each year, Financial Aid is required to check to ensure that each student has met the minimum requirements for SAP. Please review the requirements <a href="https://example.com/here">here</a>. Students who do not meet the minimum requirements will receive email notification and will not be eligible for Financial Aid for the 24-25 school year (FastPass and FastPass Lite are excluded). Students will be given the opportunity to complete a SAP Appeal Form.

Are you planning to Graduate this Summer or Fall? NOW is the time to submit your intent to graduate form. **To** access the form, log in to <u>myEastern</u> with your student username and password, and look for Academic Profile under the Self-Service menu. Graduation Application will be one of the choices underneath Academic Profile.

## Taking Summer Courses Elsewhere

If you'd like to take summer courses at another institution, remember to get them approved first by using the Permission to Take Coursework Elsewhere form! If the course is a 100-level general education or elective course, you can use our online form found <a href="here">here</a>. If it is a higher level course, or required for your major, please use our paper form so you can get the required approvals before submitting to the Registrar's Office. We have copies of the form in Mall Cottage, or you can <a href="mailto:print it">print it</a>.

Once you have gotten approval from the Registrar's office to take the course, you will register directly with the other university. Once you complete the course, request that an official transcript be sent to the Registrar's office and we will add the credits and grade to your Eastern record. If you have any questions about this process, please visit Mall Cottage and we'll be happy to help you!

## Fall 2024 Registration is Open NOW!

All returning students are required to submit a <u>Preregistration Survey</u> prior to being eligible to register. Contact or meet with your Academic Advisor to approve your planned courses. Depending on your program, you may not be able to register without approval from your advisor.
