## Summer 2026 Registration

Have you registered for your Summer 2026 courses yet? If not, reach out to your academic advisor as soon as possible for assistance. It's important to enroll in all of your Summer 2026 up front to ensure your bill and financial aid are accurate.

## FastPass & FastPass Lite

For students who qualify to enroll in FastPass courses, it's important to file your 26-27 FAFSA now to ensure we can process your FastPass awards for this summer. File your 26-27 FAFSA at StudentAid.gov.

## Student Account Services – Ways to Pay Your Bill

**Your student account must be up to date to register for Summer and Fall classes. A hold will be placed on your account if you owe money from previous terms.** Please monitor your EU email for important notifications and balance due reminders from Student Accounts. Stop in or schedule a virtual appointment to discuss your account, make a payment or discuss payment plans. If you have a balance due now on your Student Account bill or you are anticipating a future balance in an upcoming term, check out these options:

**-Federal Graduate PLUS Loan (for Master's and Doctoral students only)**

## Coursework Elsewhere

If you'd like to take Spring courses at another institution, remember to get them approved first by using the Permission to Take Coursework Elsewhere form. If the course is a 100-level general education or elective course, you can use our online form found [here](#). If it is a higher level course, or required for your major, please use our [paper form](#) so you can get the required approvals before submitting to the Registrar's Office.

## Spring 2026 Reporting Term Disbursement Date/Electronic

The Spring Reporting Term Disbursement Date is March 24, 2026. Refunds will be issued by the Student Accounts Office within 10 business days after the funds have been applied to the bill and there is a credit. We strongly recommend signing up for E-Refund (direct deposit) under the Students section of my.Eastern.edu, via the Banking Information tab.
