Parent Proxy Access

We are excited to announce the release of our new Self-Service **Proxy Access** that is now available for the Fall 2024 term!

Proxy Access provides students with the ability to grant permission to their parents or guardians to access certain information.

- Set up a payment plan
- Check to see if a payment has been received

2024 Fall Reporting Term Federal Loan Disbursement Date/Electronic Refunds

The Fall Reporting Term Disbursement Date is November 5, 2024. Refunds will be issued by the Student Accounts Office within 10 business days after the funds have been applied to the bill and there is a credit.
