If you'll be taking courses in Summer 2023, make sure to file your [23-24 FAFSA](#) now at StudentAid.gov. For FastPass or FastPass Lite eligible students, you'll receive an updated aid package with your summer FastPass financial aid listed.

## Summer 2023 Student Employment

Email notification regarding applying for Student Employment for the summer was sent out the week of March 5. Every student who would like to work on campus during any portion of Summer 2023 MUST complete the Summer 2023 Employment Application. The link for this can be found in the email. It is not a guarantee of employment, but it allows Student Employment to know who is interested in working this summer, what funding options are available, and it allows HR to get all necessary employment paperwork prepared.

## May 2023 Graduation Information

If you plan to finish your degree this Spring and have not applied for graduation, now is the time! All students expecting to graduate in May should have their Application for Graduation submitted by April 1st. To access the form, log in to <https://my.eastern.edu/> and, under the Self-Service menu, click on Academic Profile, then Graduation Application. First day of SP2/Last day to register for SP2: **March 6**

Last day to add/drop SP2: **March 13**

Last day to Withdraw\* from Spring 22 classes: **April 26**

Last day to Withdraw\* from Spring 2: **April 23**

Good Friday/Easter Holiday: **April 7**

Last day of Spring 2: **April 26**

**\*Without academic penalty; course stays on record and bill with a grade of "W" that does not affect GPA. Please use the form "Withdraw from Course without Academic Penalty" available on the Registrar Forms Section of the EU website.**

Registration for Summer and Fall 2023 will open the week of April 3, 2023! Please monitor your Eastern email account for important updates regarding registration information and your specific registration dates.
