Taking Summer Courses Elsewhere

Current students who desire to take a course outside Eastern over the summer, even through an online program, must complete a 'Permission to Take Coursework Elsewhere' form. Please visit the Forms page of www.eastern.edu/Registrar to find this form. The form MUST be submitted to the Registrar's Office prior to taking the course, to confirm approval and transfer equivalency. If you would like a course(s) taken into account for Financial Aid purposes, you must also complete a [Consortium Agreement for Coursework Elsewhere](#).

Student Accounts Bills & Payment Plans

Summer 2022 bills and payment plans are now available on your my.Eastern.edu account. *Please monitor your EU email for important notifications and billing due dates.* The Summer 2022 payment plans are open for enrollment at <https://payplan.officialpayments.com/PlanEnrollment/SelectEntityStep.aspx>

The "Withdraw from Course(s) Without Academic Penalty" deadline has recently changed. This means that you can now withdraw from a class and receive a grade of "W" which will not impact your GPA up until the last day classes are scheduled to meet (not the last day of exams).
