#### **Position Summary**

This includes, but is not limited to also supporting development and implementation of associated policies and initiatives. Working collaboratively with colleagues within the IPE office and across the University, the Research Associate supports the institution's compliance in data reporting and ensuring institutional effectiveness and contributes to fostering a culture of collaborative and data-informed decision-making.

- Conducts data analysis to support the University's initiatives, priorities and planning goals.
- Assists in managing the office's survey administration, including analysis and distribution of results.
- Provides support for the institution's specialized and institutional accreditation activity, including data support, analysis and report completion.
- Assists with the institution's state authorization activity, including data collection, analysis and reporting.
- Works closely with the IR and IE staff to organize and execute research projects, identifying ways to improve research design and data validity.
- Provides guidance and training to University users of IR/IE data and reports.
- Serves on institutional committees as requested by the COS/Vice President and/or Director of IR.
- Attends University meetings and events as required.
- Embodies Eastern University's core values of excellence, authenticity, stewardship, thoughtfulness, enthusiasm, relationships, and innovation.

# **Background Checks**

In accordance with state laws, Act 73 of 2007, Act 153 of 2014, Act 168 (relating to the Child Protective Services Law), school employees of Eastern University who will have "direct contact with children" must complete the background check process prior to employment. Results must be submitted within ten days of receipt.
